How Important is the Concept of a Planetary “Network of Voices” for Citizen Diplomacy with Extraterrestrials?

Introduction

On behalf of all inhabitants on Earth, who will officially answer the call once contact with advanced extraterrestrial civilization is recognized? The current population of planet Earth has exceeded eight billion peopleⁱ. This does not include the plants, the various forms of wildlife, cetaceans in the oceans, and the other lifeforms that co-habitat the planet, nor does it include ancient or advanced civilizations of Inner Earth, living in subterranean areas. Thus, many species and various human races call Earth ‘home’.

Some ancient civilizations have been in contact with other galactic races, as well as claiming their race has been here long before others. Hence, since humanity is the only recognized intelligent species on the planet, this will complicate matters in the future when it is time for establishing a communication network with other intelligent civilizations on Earth. Shouldn’t all species and races of Gaia want to be heard and represented within a network? Further, since surface humanity is not nearly as evolved spiritually or technologically as other civilizations, perhaps other advanced Earth civilizations would guide Earth humans in establishing a network of communication with all beings.

Let us first ask: what is a ‘Planetary Network of Voices’? In my own understanding, it is a network of communication amongst all residing beings on the planet, which includes surface humanity, lifeforms such as plants, animals, bacteria, cetaceans, other advanced civilizations in subterranean regions, and all who call Earth ‘home’. Additionally, conversations with extraterrestrials have been ongoing for decades.

One must ask, is surface humanity prepared for contact with extraterrestrial civilizations? Because Earth has many nations, who speaks and develops legislation for appropriate procedures in regards to advanced extraterrestrial life? Importantly, militaries throughout the world concerned with national security would want the conversation controlled or kept to a minimum when it comes to ET life. In addition, the United Nations openly discussed UFOs and may be a key component in a planetary network of voices. UFOs and UAPs have even made their way into the mainstream mediaⁱⁱ and the House Oversight Committee held a hearing in July 2023.ⁱⁱⁱ

Lastly, humanity engaging in other Track One or Track Two Diplomacy must be cautious of deception from other races that claim to want to help humanity awaken and rejoin a larger network of voices on our planet and beyond.

United Nations General Assembly Decision 33/426

On December 18, 1978, in its 87th plenary meeting, the United Nations General Assembly, on the recommendations of the Special Political Committee, recommended an agency or department handling and coordinating results into the research of the UFO phenomena: UN General Assembly Decision 33/426.^{iv}

"1. The General Assembly has taken note of the statements made, and draft resolutions submitted, by Grenada at the thirty-second and thirty-third sessions of the General Assembly regarding unidentified flying objects and related phenomena.

"2. the General Assembly invites interested Member States to take appropriate steps to coordinate on a national level scientific research and investigation into extraterrestrial life, including unidentified flying objects, and to inform the Secretary-General of the observations, research and evaluation of such activities.

"3. The General Assembly requests the Secretary-general to transmit the statements of the delegation of Grenada and the relevant documentation to the Committee on the Peaceful Uses of Outer Space, so that it may consider them at its session in 1979.

"4. The Committee on the Peaceful Uses of Outer Space will permit Grenada, upon its request, to present its views to the Committee at its session in 1979. the committee's deliberation will be included in its report which will be considered by the General Assembly at its thirty-fourth session."

Appropriate legislation was taken by the UN General Assembly in 1978, however, there has never been action publicly taken by the UN since the 87th plenary meeting regarding UFOs. Nonetheless, the UN is aware and is paying attention to the UAPs / UFOs in the sky, and how they may impact the environment and life on Earth is still unknown at this time.

National Security

On February 19, 2019, U.S. President Donald Trump released Space Policy Directive-4 which established America's Space Force.^v The Space Policy Directive introduction reads:

Space is integral to our way of life, our national security, and modern warfare.

Space Policy Directive-4 Introduction continues:

It is imperative that the United States adapt *its national security organizations* (emphasis by GK), policies, doctrine, and capabilities to deter aggression and protect our interests. Toward that end, the Department of Defense shall take actions under existing authority to marshal its space resources to deter and counter threats in space, and to develop a legislative proposal to establish a United States

Space Force as a sixth branch of the United States Armed Forces within the Department of the Air Force.

Complicating matters of a planetary network of voices is national security, which may limit conversation between ET civilizations and civilians (more on Track Two Diplomacy later), with governmental agencies listening nearby. Hence, branches of the military, such as the Space Force, will need to be included in any conversation as it will most likely be deemed necessary in regards to maintaining national security. It is evident that the Space Force is prepared to directly deal with advanced civilizations who possess amazing technology that can transform the planet and aid inhabitants of all kinds.

Other Life Forms on Earth

Other than humanity, plants, and animals, what other intelligent life and forms of life reside on the planet? Cetaceans such as dolphins are said to have advanced intelligence, with psychic abilities. Additionally, they have the ability to communicate with humans and ETs^{vi} alike.

It is difficult to deny that dolphin behavior is passed down from previous generations, and they interact socially in a complex manner similar to humans, and their brains possess key features that suggest high intelligence.^{vii} In the article *Dolphins as Persons*, Dr. Lori Marino of Emory University elaborates:

Dolphins have distinct personalities, a strong sense of self, can think about the future, and have the innate ability to learn language - their own, and remarkably a rudimentary symbol-based language created to bridge the communication chasm between dolphins and the human species.

Additionally, Argentina granted some basic rights to Sandra, an orangutan at the Buenos Aires Zoo in 2014.^{viii} Paul Buompadra, a lawyer for Argentina's Association of Professional Lawyers for Animal Rights (Afada) stated:

This opens the way not only for other Great Apes, but also for other sentient beings which are unfairly and arbitrarily deprived of their liberty in zoos, circuses, water parks and scientific laboratories.

To add to this point, imagine a world where not only chimpanzees would be seen as 'persons', but also cetaceans and other non-human life would be granted basic rights. A quick reminder that African Americans did not receive basic human rights until after the conclusion of the American Civil War in the 1860s. And the 19th Amendment gave women the right to vote was not ratified until August 18, 1920.

Earth-based Reptilians

A 'female reptile' calling herself 'Lacerta', claimed in a December 1999 interview, that her reptilian race is, "*The native terrans* (emphasis by GK) and we live on that planet since millions

of years (sic).”^{xix} Lacerta claims that she belongs to a reptilian race that has been established on Earth for ‘millions of years’. It is certain that when it comes time to establish a network of voices, Lacerta’s native reptilian race would want to be heard.

In October 2004, Angela Whitecliff^x interacted telepathically with an Earth-based reptilian named Jar, who identified himself as an ambassador for an Earth-based reptilian civilization.^{xi} Jar respectfully desired to offer assistance to surface humanity for contractual considerations for his people, who reside in the United States (New Mexico, Utah, Colorado, Arizona and, Northern California), the Middle East, and South America. According to Jar, there are three great Reptilian cities called Shal, Uhr, and Bar Ber, which represent two-thirds of the earth-based reptilian population.

Although Whitecliff established what seemed like a solid track two diplomatic connection (see **Track Two Diplomacy** below), she became aware that Jar may be deceptive (see **Grays (Greys)** below). It is important that humanity filter out deception and manipulation from other Earth-based or non-Earth-based civilizations who may not have Earth’s best interests in mind. On the contrary, Jar did seem interested in 1) supporting humanity in the awakening process, 2) assisting technologically in nullifying Draconian mind-control technologies, and 3) ‘strength in numbers’ to act as bodyguards on humanity’s behalf.

Grays (Greys)

Phil Schneider^{xii}’s whistleblower testimony^{xiii} in 1995 alerted humanity that Grays have established underground bases, such as in Dulce New Mexico, where he worked, and throughout the United States. Additionally, Grays are connected to the abduction phenomena. On a side note, reptilian ambassador Jar claims that the Greys are surface humanity’s problem, and he offered no assistance in dealing with them.

Insectoids

Another common phenotype, who are also associated with the abduction experience, are insectoids.^{xiv} Although not much is known about insectoids populating planet Earth.

Inner Earth Civilizations

Whistleblower Corey Goode shed light on an advanced civilization that resides within the subterranean regions of Earth. In his blog^{xv} from September 2015, Goode discusses an Ancient Earth Council, comprised of humanlike races. Goode’s primary contact, a high priestess, Kaaree of the Anshar, says to be 130 years old, with youthful features. Dr. Michael Salla believes that Goode is a genuine source, and therefore the Inner Earth civilizations should be accounted for when establishing a network of voices. Similarly, contactee Luis Fernando calls the Inner Earth Beings the ‘Elders’, and they belong to what is called the ‘Great White Brotherhood.’

Arcturian Founders

According to Lyssa Royal-Holt in *The Prism of Lyra: An Exploration of Human Galactic Heritage*^{xvi}, Arcturian Founders genetically engineered key prototypes with the intention of bringing balance to Earth Humanity. According to Germane (Lyssa's multidimensional consciousness contact):

The prototypes were taught about consciousness, unified fields, and the mind body connection.

Additionally, once they graduated, it was the Founder's intentions to seed, reproduce in Asia, and parts of Polynesia and Indonesia. Significantly, Germane, a multidimensional consciousness, reveals that:

... the Arcturian Founders who went underground *are still there* (emphasis by GK). They are the caretakers. They are the beings you refer to now as the Inner Earth Beings. They are very old; they have been here for a very long time.

Although it will come as a shock to many that ancient beings reside on Earth, the Arcturian Founders seem to have humanity's best interests in mind, and one may ask what humanity can learn from them once a network of voices is officially established. It is worth noting that these same beings housed positive Atlantean priests after the destruction of Atlantis. Atlantis had many outposts, and many of its inhabitants spread globally and assisted in the growth of ancient civilizations such as Egypt and South America.

Ascended Beings Below the Pyramid

In Claire Heartsong's *Anna Grandmother of Jesus*,^{xvii} a forgotten historical figure, Anna, who had mastered physical age and assisted her grandson Jesus (Yeshua), and his companions along their journeys to ascension, tells of ascended masters who manifested in physical bodies. Along with his brother James and cousin John, Yeshua met his ancestor, Akhenaten, along with other enlightened beings at the secret chamber in Abydos for the purpose of seeding the ascension codes for humanity.

Although Heartsong's book features Anna's divine channelings, and it is unlikely these ascended beings would remain in the physical form for millennia. However, surface humanity would benefit from the pure messages from Anna that would help achieve higher consciousness for all of Gaia's inhabitants.

Track One Diplomacy

Deemed as 'Track One' or 'official' diplomacy, officials within national states such as the United States or sub-national (one of the fifty states), multilateral such as the United Nations, or supranational such as the European Union^{xviii}, can interact and come to agreements in secret with extraterrestrial races, without the public's consent or knowledge. Although officials within these organizations are either elected or serve in appointed positions, they claim to represent their population, but do they represent *all* within its boundaries?

Agreements reached between the above entities and extraterrestrial civilizations may agree on a trade for technology, but this is still done without the knowledge and consent of the mass population. Further, it has been dialogued dating back to at least the Eisenhower Administration in the 1950s that Track One diplomacy has been in practice with both benevolent, but mostly malevolent extraterrestrial civilizations. Benevolent ETs concerned themselves with the USA and other powerful nations moving away from nuclear use, while beginning to incorporate more spiritual-related philosophies. On the contrary, malevolent ET groups may be more focused on extraction and manipulation of human genetics and DNA, as well as human abductions.

An area of emphasis is to resolve any potential conflicts that may arise between nations or races. It is difficult to remain equal, especially when communicating with technologically superior advanced civilizations.

Track Two Diplomacy

Track Two diplomacy consists of citizen-led discussions with advanced, benevolent civilizations. Hence, contactees throughout many nations for many years qualify as potential track two diplomats. Track Two or citizen diplomacy consists of individuals not affiliated with the government, yet these individuals are engaged in communication with foreign or non-domestic entities. In this instance, these foreign entities include extraterrestrials. These diplomats frequently act as a third party, and are informal, or unofficial individuals who work outside official negotiation procedures. Additionally, Track Two diplomats explore ideas of resolution in a safe, non-coercive, non-judgmental environment, where the goal is to problem solve between two parties.^{xix}

Thus, why would our world need citizen diplomats? The answer is to resolve any potential conflicts that may arise between entities.

There is a strong likelihood that a planetary network of voices would feature both Track One and Track Two diplomacy when finding resolution between differing ideas, perceptions, and agendas.

Hawaii Declaration

During a June 2006 conference focused on Extraterrestrial Civilizations and World Peace, civilians, chaired by Dr. Michael Salla, and participants declared intentions for humanity to join peacefully and cooperatively with benevolent ET civilizations.^{xx}

The highlights of the declaration among the participants included:

- 1) cooperating peacefully with ET civilizations,
- 2) support for the United Nations in promoting peace in Outer Space
- 3) affirming the natural right of all citizens to have open contact with representatives from ET groups.
- 4) declaring the need for Civil Society to develop acceptable protocols.
- 5) cooperating with ET groups to promote Earth, Cosmic, and Life friendly technologies.

- 6) affirming the desire to coordinate the Earth's ecological and biological health and
- 7) expressing desire to welcome the open appearance of benevolent ET groups.

Unfortunately, this declarative movement did not survive in the long run and does not remain active today. However, this intention is very promising because establishing a planetary network to communicate between citizens and ET civilizations, would be recognized by the state governments. Although Hawaii stands alone in regards to standing peacefully with other civilizations, the other 49 states can use Hawaii's declaration as a template for inspiration for to establish relationships with benevolent ET groups, who hold humanity's best interests.

When and if these declarations are created in the future, here are some key points that should be considered if surface humanity is going to maintain a successful network of communication:

Revised Recommendations

1. State declarations with citizen signatures focused on cooperation and peaceful relations with ET groups (e.g., Hawaii).
2. Raising awareness and writing to state legislatures demanding follow through and cooperation regarding communication with ET civilizations (I do not recommend using social media such as X (formally Twitter), Facebook, Tik Tok, etc.).
3. Creating and enforcing legislation making it illegal for private citizens, private companies, and governmental agencies to profit from advanced technology.
4. CE5 with benevolent extraterrestrials
 - a. hosting citizen-led conferences with a focus on contacting peaceful extraterrestrial races who value our human race and establishing declarations, if necessary.
 - b. Official documentation of meetings between civilizations and extraterrestrials with transcripts that can be retrieved at any time.
5. Providing education on truthful ET civilizations, UFOs / UAPS (e.g., such as through the Exopolitics Institute^{xxi}), and sifting out false information (intentionally disseminating false information needs to be considered a crime as well).
 - a. Focuses on the study, support, and promotion of the growing scientific field of Exopolitics (I want to emphasize that individuals educated in Exo studies should be considered to potentially lead locally or possibly at a state or federal level).
 - b. Non-profit organizations that offer a certificate or diploma for qualifying candidates (*GK input: the jobs for graduates who hold a diploma may not exist yet, but in the future one must remain hopeful*).

Concluding Remarks

A planetary network of voices may take many years to properly establish and remain effective if the inhabitants of Earth are going to collaborate, accept one another's differences, and resolve any conflicts over people, policy, territory, and other matters that may arise. Of the eight billion recognized surface humans, other intelligent beings which includes civilizations residing inside

the Earth, cetaceans, and other living organisms, it is vitally important that we come to an understanding amongst one another, co-exist, share resources, and when problems present themselves, to collaborate to create solutions that benefit all parties as accurately as possible.

To offer an example of understanding, surface humanity is currently not as spiritually advanced as other civilizations. Our humanity possesses technology that may not be beneficial to humans or the environment, such as the use of fossil fuels and nuclear energy. If and when humanity is open to it, it can look to a more advanced civilization to educate why fossil fuels and nuclear energy are harmful to living organisms and the biosphere.

In conclusion, it is going to take strong, educated, and willing leaders to maintain a planetary network of voices. Governmental agencies, the military, and elected representatives currently have greater access to classified information and may hold a ‘need-to-know’ status when it comes to national security. However, do not discount Track Two diplomats who have an avenue to enter unofficial relations with advanced civilizations. It is clear that honesty, transparency, and cooperation on all extraterrestrial, UAP / UFO matters is required and necessary if humanity is going to have an effective network of communication.
