Contemporary Citizen Diplomacy Initiatives with Extraterrestrials

Introduction

The willingness of citizen-led initiatives to establish peaceful relations with benevolent extraterrestrial civilizations has been no secret and is already in the works from multiple private citizens and organizations. In some instances, private citizens have been working towards getting the federal government to take the UAP (Unidentified Aerial Phenomena) / UFO issue seriously. Although it is a small sample size, some of these individuals include Dr. Steven Greer, Stephen Bassett, and the organized citizens of Hawaii in 2006.

Goals of these individuals and organizations include establishing peaceful relations, releasing AT (advanced technology) to the tax paying citizens, ending nuclear testing, protecting whistleblowers, and engaging in citizen-led track two diplomacy with peaceful ET groups. Despite years of failure of lobbying congressional officials, intimidation, and too frequently, execution, the 2020s is primed for UAP / UFO disclosure.

Paradigm Research Groupⁱ

UFO activist and lobbyist Stephen Bassett has been advocating for the government to reveal its secrets regarding UFOs. Bassett has been active in the UFO community for 26 years, and among things, finds the ET connection with the Clintons fascinatingⁱⁱ and asks questions that have never been taken seriously, or have publicly been answered by any Clinton or Obama administrative figures.

In addition, Bassett asks questions on what the world will look like just prior to and after disclosure. One day, will the President of the United States formally admit that ETs exist, and that UAPs are not just 'unexplained'? Is society going to wait for approval from our federal governments worldwide? One goal of Bassett's is to get a formal acknowledgment from the US Government about the extraterrestrial presence.ⁱⁱⁱ Whether this happens or not, Bassett has contributed with many conferences, TV appearances, and over 500 written articles on through the media.

In July 2022, multiple CEOs including Jeff Bezos^{iv}, Elon Musk^v, and Richard Branson^{vi}, ignited speculation in the Exopolitical community that their travel to outer space was more than just recreational and a media scrum. Dr. Michael Salla, along with his contact Elena Danaan, confirmed that a group of space-faring nations with multinational CEOs were flown to Jupiter to negotiate Earth's future place in our solar system^{vii}. Although the three CEOs may not be seen as 'trustworthy' in the eyes of the galactic civilizations, in an impending emergency like a solar flare, they potentially possess the capabilities to organize and transport many civilians out of the way of danger. Hence, if this report is accurate, it serves as a strong example of private corporations asserting themselves within the lines of diplomatic relations with extraterrestrials. In a hypothetical scenario, the CEOs may act without a green light from their respective national governments.

National Press Club Event, Dr. Steven Greer

June 12, 2023, Washington D.C.

An objective approach to diplomacy with extraterrestrials first starts with a disclosure movement by Dr. Steven Greer. On June 12, 2023, Dr. Greer, founder of the Disclosure Project^{viii}, held a Press Club Event in Washington D.C.^{ix} that focused on the secret world of Unidentified Aerial Phenomena (UAP) the effort to silence individuals and witnesses tied with UAP / UFO related projects. For decades, individuals have been threatened, intimidated, and often executed for their involvement in classified projects that entail highly advanced, and frequently dangerous technology that may be harmful to humans and the environment.

Individuals who have come forth in the Disclosure Project initiative are aided by the Whistleblower Protection Act (WPA) that protects individuals who “make disclosures described in section 2302(b)(8) of title 5, United States Code, serve the public interest by assisting in the elimination of fraud, waste, abuse, and unnecessary Government expenditures; (2) protecting employees who disclose Government illegality, waste, and corruption is a major step toward a more effective civil service.”^x In the United States, Federal employees are covered under the WPA if they choose to disclose information that may violate the law, and extends to abuse of funds and the safety of the public.

The upholding of legislation, such as the WPA, protects individuals who choose to bring forth information to help expose illegal activities. Hence, this may lead to the prosecution of alleged individuals associated with illegal actions, such as endangering federal employees, and in some instances, the environment. In addition, releasing technologies that will help billions around the world end poverty, environmental destruction, and solve the world energy crisis are the most important focuses in this civilian-led disclosure initiative. However, according to Dr. Greer, these illegal activities orchestrated by private corporations have acted without consent or knowledge of the government.

It has been well dialogued that a shadow government has been operating without governmental oversight for decades, including as far back as the Eisenhower Administration in the 1950s. On January 17, 1961, President Dwight Eisenhower in his farewell speech to the nation, offered a stern warning on the dangers posed by the MIC (Military Industrial Complex):

In the councils of government, we must guard against the acquisition of unwarranted influence, whether sought or unsought, by the military-industrial complex. The potential for the disastrous rise of misplaced power exists and will persist. We must never let the weight of this combination endanger our liberties or democratic processes. We should take nothing for granted. Only an alert and knowledgeable citizenry can compel the proper meshing of the huge industrial and military machinery of defense with our peaceful methods and goals, so that security and liberty may prosper together.^{xi}

President Eisenhower's message remains relevant in 2023, each decade since has consisted of secrecy and rogue agencies operating without presidential, congressional, or any form of official oversight. Hence, the WPA was not yet established in the 1960s, and could have played an integral role in the power struggle between the Eisenhower Administration and the shadow government, which most likely included the Majestic-12, a control group outside the reach of the executive branch.

Eisenhower states, "Only an alert and knowledgeable citizenry," or in other words an 'informed citizen', who can look at a situation from an objective perspective, can make proper and informed decisions that can benefit society. Of the many intrigues and parallels dating back to the Eisenhower Administration, the group known as the Majestic-12 most likely consisted of governmental officials in both the FBI and CIA, as well as scientists who were private citizens or contractors for the government.

Who?

Those who accompanied Dr. Greer were a variety of whistleblowers from diverse backgrounds such as military, science, governmental contractors, and attorneys, who shared their testimonies and experiences from events that they were 'not supposed to see'. One witness who spoke on June 12th, D.C. Long, formerly of the U.S. Army, faced immediate consequences for simply witnessing, in passing, a monolithic slab that weighed approximately one-hundred tons with 'nothing holding it up.' Within twenty-four hours, his father's business possessions were seized, including small items such as pencils. Following this, Long and his father's lives began to spiral downward.

Long is an example of a small percentage of individuals who had their lives torn apart simply because people wanted to keep secrets.

During media time, Dr. Greer reiterated that he would not give any names or names of corporations who participated in illegal activities. Primarily because it could jeopardize his citizen-led initiative.

What? The Danger

The real danger is not UFOs / UAPs, but the secrecy that surrounds them, and the misuse of power and billions of taxpayer dollars that have been spent without the knowledge of taxpayers. Hypothetically, what would our world look like without the intentional destruction and raping of the planet's resources that pocketed billions of dollars into the energy companies such as oil, electric, and gas? In book 7 of the *Secret Space Program Series*, Dr. Salla discusses the impact of the discovery and recognition of advanced civilizations and their technology. Salla points to the Brookings Report^{xii}, "How might such information, under what circumstances, be presented or withheld from the public?" The report states:

Of all groups, scientists and engineers might be the most devastated by the discovery of relatively superior creatures, since these professions are most clearly associated with mastery of nature.^{xiii}

Thus, when AT (advanced technology) is accessible to the public, society must prevent total economic collapse when the energy industry may no longer be needed. Although this would severely help the planet, nature, and human beings, we must be careful not to deliver such a shock to the mass public and the economy by exposing corruption of clandestine activities and releasing free technologies that will completely sink the energy industry financially.

When?

‘A clock has been set for six months’ (from June 2023) according to Dr. Greer for Congress to act on the UAP / UFO secrecy. Otherwise, Dr. Greer and his team of attorneys intend to subpoena the individuals and corporations within the control group responsible for ‘shadowy’ conduct operating without presidential or congressional oversight. To avoid any conflict with this shadowy group or groups, we first must attempt a peaceful transition of exchanging technology. Additionally, we want to avoid any false flag^{xiv} attack that could be catastrophic to the planet and its inhabitants. As presented by Eric Hecker, former Raytheon contractor located at the South Pole, that the Deep State / Shadow Government possesses AT that can generate earthquakes and be used for other nefarious purposes.

How? Solutions for Disclosure

Dr. Greer admits that he has never had a security clearance for anything. One does not have to be a member of the military, the government, or a governmental agency to get involved with the bringing to light of crimes against humanity. What is going to stop millions of people from putting forth their authentic testimonies with ET civilizations? Greer has given CE5 experiencers and contactees a platform to interact and share. Disagreement on “Bad ETs”

Dr. Greer preaches that *all ETs are benevolent* and want to help humanity break free from the select humans with advanced technology. Although Dr. Greer wants to take a peaceful approach and cautions not to bring a knife to a gun fight, society must brace itself to the idea that there are malevolent ET civilizations who do not have the best intentions for Earth’s civilians, environment, and its resources.

Many researchers will argue that although there are countless benevolent ET civilizations, there also exists malevolent ET groups that have infiltrated and controlled humanity from the shadows, and ultimately have secretly agreed to exchange technology with governments unbeknownst to the mass population of Earth. Communication from malevolent ETs rewinds back to at least pre-Nazi Germany when Draco Reptilians communicated with German secret societies. Hitler valued

these communications and took a strong interest in what these dark civilizations could provide for him. As first reported by Benjamin Fulford^{xvi} and also Michael Salla^{xvii}, the Dark Fleet reached a deal with US and global authorities that would disclose its existence and the incredible technologies unbeknownst to the public. Although this deal was allegedly reached through governmental diplomats, it has been over five years since the agreement was reported. If citizens can prove this agreement to be true, this would be a logical avenue to pursue and a step towards disclosure.

Hawaii Declaration on Peaceful Relations with ETs

June 9-11, 2006, Kona, Hawaii

During a June 2006 conference which focused on Extraterrestrial Civilizations and World Peace, civilians, chaired by Dr. Michael Salla, and participants declared intentions for humanity to join peacefully and cooperatively with benevolent ET civilizations.^{xviii} Participants then adopted a declaration. Highlights of the declaration include:

- 1) cooperating peacefully with ET civilizations,
- 2) support for the United Nations in promoting peace in Outer Space
- 3) affirming the natural right of all citizens to have open contact with representatives from ET groups.
- 4) declaring the need for Civil Society to develop acceptable protocols.
- 5) cooperating with ET groups to promote Earth, Cosmic, and Life friendly technologies.
- 6) affirming the desire to coordinate the Earth's ecological and biological health and
- 7) expressing desire to welcome the open appearance of benevolent ET groups.

This is a very promising step towards unofficial citizen diplomacy with galactic civilizations. Although Hawaii stands alone in regards to standing peacefully with other civilizations, the other 49 states can use this as inspiration and a template for declaring and establishing relationships with benevolent ET groups, who hold humanity's best interests.

Below I have developed a personal list that may be useful for future citizen diplomacy:

Citizens Leading the Charge by

1. Raising awareness and writing to state legislatures demanding follow through and cooperation regarding UAP / UFO technologies and how they can benefit society – domestic and foreign.
2. State declarations with citizen signatures focused on cooperation and peaceful relations with ET groups (e.g., Hawaii).
3. Subpoenaing individuals and private corporations that have reaped the benefits of AT, without looping in state or federal governments, or the consent of citizens.
4. CE5 with benevolent extraterrestrials (e.g., Greer's CE5 app)

- a. hosting citizen-led conferences with a focus on contacting peaceful extraterrestrial races who value our human race and establishing declarations, if necessary.
- 5. Providing education on ET life, AT, UFOs / UAPS (e.g., such as through the Exopolitics Institute^{xix})
 - a. Focuses on the study, support, and promotion of the scientific field of Exopolitics.
 - b. A non-profit organization that offers a certificate or diploma for qualifying candidates (*GK input: the jobs for graduates who hold a diploma may not exist yet, but in the future one must remain hopeful*).

Concluding Remarks

With the veil of secrecy that remains over the citizens of Earth, one must remain optimistic that benevolent extraterrestrials and the incredible technology that will help the inhabitants and the biosphere, will one day soon positively impact life on our planet. The road is being paved for citizens to come forth and share their testimonies without fear of threat, intimidation, or execution, as displayed in Dr. Greer's Press Event from June 12th. Many individuals, including Dr. Greer, have dedicated their lives to lifting the veil on all UFOs / UAP related matters, sharing their testimonies, and acting in accordance with the law, and in peaceful manners.

The importance of Hawaii's declaration to establish peaceful cooperation should not be overlooked. If each state scripts and establishes its own declaration, the federal government in turn, will not be able to suppress the secrets of ETs and their technologies any longer. Silence for decades indicates that we must consider track two diplomacy with ETs, and not wait for governmental approval. Importantly, like Hawaii, each state's declaration will be drafted by private citizens to participate in and pass up to their state legislature. Dr. Greer, in addition, emphasizes the importance of writing to one's state representatives regarding the release of UFO documentation and technologies. Clearly, technologies exist that can help humans and the planet right now. In conclusion, by raising awareness and by people coming together as one, along with all inhabitants living in all environments, in a peaceful manner, such as through legislation, we can move forward to become acclimated with other intelligent civilizations that inhabit our solar system and beyond.
